**FINDINGS OF THE ARBITRATOR
AS TO FOUR WINDS INTERNATIONAL**

AS TO FOUR WINDS THERE WAS INSUFFICIENT DOCUMENTATION TO SUPPORT THE CONSUMERS' CLAIMS INVOLVING LEAKS IN THE CAB OF THE VEHICLE. THE CONSUMERS REFUSED TO ALLOW FOUR WINDS A TIMELY REQUESTED FINAL REPAIR OPPORTUNITY.

CONCLUSIONS
